## “ART FOR ALL SEASONS” EXHIBIT CONTRACT

This is an agreement between Maude Kerns Art Center, an Oregon non-profit corporation hereafter referred to as the Art Center, and the undersigned Art Center member, summarizing and disclosing the rights and responsibilities of those two parties.

All work must be suitably presented and ready to hang and/or install. All artwork is hung subject to space availability. Artists may exhibit two, ready-to-hang pieces or one large, ready-to-hang piece. If submitting two pieces, each ready-to-hang piece cannot exceed 36" vertically and/or horizontally. A large piece is considered any ready-to-hang artwork that exceeds 36" vertically and/or horizontally.

The Art Center will not be responsible for damage caused by poor technique, materials, preparation, and/or presentation methods including hanging hardware that deviates from gallery standard wire hanging. Any pieces so damaged will not be exhibited. The Art Center is not responsible for damage, theft, or destruction during transportation to and from the Art Center. There is a display fee of \$5 per piece.

The Art Center will retain 40% commission on all artwork sold during the exhibit. The artist will also, in good faith, pay commission of 40% to the Art Center for work sold 30 days after the exhibit, but viewed by the purchaser while on display at the Art Center.
